Description of Proposed Project

The Harris-Galveston Subsidence District (HGSD) and Fort Bend Subsidence District (FBSD) have established requirements for entities within their boundaries to limit groundwater pumpage to a specified percentage of total water use to address the issue of land surface subsidence caused by prolonged heavy pumping from the Gulf Coast Aquifer; as demands are expected to grow with time, the allowable percentage from groundwater is scheduled to decrease. In order to meet these requirements, City of Houston (COH), North Harris County Regional Water Authority (NHCRWA), and Central Harris County Regional Water Authority (CHCRWA) are developing a large shared pipeline to convey treated surface water from the COH Northeast Water Purification Plant (NEWPP), which is under contract to be significantly expanded.
