Description of Proposed Project

Water use in Junction in 2013 shows 523 acre-feet (AF) withdrawn and 242 sold to customers. Some of this volume goes to commercial users and for system maintenance, but much of it is attributed to line losses. Estimated losses due to leakage of old water mains is approximately 20%! We believe potential savings are greater than the 31 ac-ft / yr listed in the Region F plan.

The project is anticipated to be approximately 8 years in length using a phased approach as to not disrupt traffic flow or access too drastically at any one time.
