Description of Proposed Project

Water rights to water in the South Llano river are only as good as the source at which the city can take. Currently, the source of water is adjacent to the Lake made by the dam in the city. Over the years, sediment has built up to the point that it is possible to stand in the middle of lake where once it was over 20' in depth. This causes water quality problems when there is a large rain event and water access issues in time of draught.

By increasing the depth of the lake back to original levels when the lake was created in the early 1960's, Junction will be able to have higher quality water with lower risk of contamination due to high non-source pollution in times of heavy precipitation. Higher "buffer" potential as well as additional storage for Junction and downstream users in time of water shortages.

This is mainly an infrastructure project required to access run of river supplies which are currently the only source of potable drinking water for residents, businesses, a regional hospital, nursing home and airport in the area.
